## Liquor and Gaming Machine Licensing

### What Do We Do Now?

#### Liquor Licensing

Processing of applications for the following:

- Managers' Certificates, Special Licences, ON Licences, OFF Licences, Club Licences, Temporary Authorities and Variations.
- Inspection of premises, investigation of complaints, recommendations for suspension or withdrawal of licences.
- Issue of all Licences.

#### Gaming Machines

- Setting of policy for Gaming Machine licences, attend to any apparent breaches of Gaming Machine Policy, and liaise with Department of Internal Affairs where appropriate.

### Tasks

Tasks are the routine matters that Council will attend to every year, in order to maintain service levels set in agreement with our community.

#### Liquor Licensing

- Administer and inspect Licensed premises in order to meet statutory requirements of Central Government.
- Promote the use of courtesy coaches by liquor providers.
- Engage in public education about responsible alcohol use.

#### Gaming Machine Licensing

- Maintain and review an appropriate Gaming machine policy, in line with policy revision cycle.

- Assist with public education about responsible gambling.

### Why Do We Do It?

To comply with the requirements of the Sale of Liquor Act 1989 and the Gambling Act 2003.

### Our Service Levels

#### Liquor Licensing:

- For issue of required reports = 15 days
- For issue of Licences = 20 days
- Advertising (twice) within 10 days

#### Gaming Machine Licensing:

- To respond to information requests from Department of Internal Affairs in a timely manner.

### Outcomes Supported By This Activity

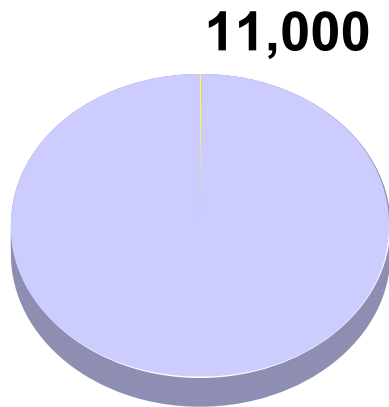

The Council will play its part in achieving the above outcomes by continuing to conduct the relevant tasks that we do now and by extending into new projects as agreed with the community.

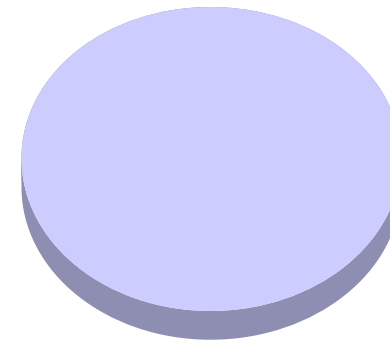
# Waimate 2020
