# **DOG CONTROL ACT 1996**

#### Section 52

The owner of any dog shall keep that dog under control at all times.

A dog will be deemed not under control -

- If it is found at large on any land or premises other than a public place or a private way without consent (express or implied) of the occupier or person in charge of that land or those premises or,
- If it is found at large in any public place or in any private way in contravention of any regulation or by-law.

You will commit an offence and be liable on conviction to a fine not exceeding \$500.00 or an infringement fee of \$200.00 if you fail to comply with this provision.

#### Section 54

The owner of any dog shall -

- Ensure that the dog receives proper care and attention and is supplied with proper and sufficient food, water and shelter: and
- · Ensure that the dog receives adequate exercise.

You will commit an offence and be liable on conviction to imprisonment for up to 3 months or to a fine not exceeding \$5,000.00 if you fail to comply with this provision.

#### Registration

Dogs over 3 months old are required to be registered. A 50% registration fee penalty will be imposed (per dog) if not registered by 1st of August each year.

All owners with dogs ordinarily kept in the Waimate District must register with the Waimate District Council.

It is an offence to keep a dog older than 3 months which is unregistered. On conviction, a Court may impose a fine of up to \$1,500.00. Any dog not wearing a collar having a current registration label or disc attached will be deemed to be unregistered. Where any dog is required to be registered after 1st August in any registration year, the fee shall be 1/12th of the annual fee for each complete month remaining in the registration year after the date of such registration.

PAYMENT Either online by visiting the Waimate District Council website www.waimatedc.govt.nz or at 125 Queen Street, Waimate.

#### **Replacement Discs**

These may be obtained from the Waimate District Council, if the current disc or tag has been lost or stolen for a fee of \$5.00.

## **False Statement**

It is an offence, in making an application for the registration of a dog, to make any written statement knowing that statement to be false. On conviction, a Court may impose a fine of up to \$1,500.00.

# **Change of Ownership**

On change of ownership of any dog, both the previous owner and the new owner, must within 14 days, give written notice of the change to the Waimate District Council.

### **Change of Address**

On the change of address of any dog or owner, the owner must, within 14 days, give written notice of the change to the Waimate District Council.

## **Transfer of Dog**

If any dog is transferred to and kept in the district of another territorial authority, other than the one in which it has been kept, for one month or more, the owner shall within 6 weeks of the transfer, give written notice of the transfer to both authorities, setting out the address at which the dog will be kept.

# Death of Dog

Where the fee for the registration of a dog is paid and that dog dies, a refund will be made on request as follows:

- Where a dog dies before the commencement of the year, the full fee will be refunded.
- Where the dog dies during the year, 1/12th of the annual fee for each complete month remaining in the registration year after the date of application for a refund will be refunded.

## **Bylaws and Policy**

The Waimate District Council Bylaws/Policy specify where dogs can be exercised, and where dogs are prohibited, along with many other general matters on dog control. # Microchipping

Dogs requiring microchipping:

- a) Any dog(s) registered for the first time (except dog(s) kept solely or principally for the purpose of herding or droving stock).
- b) Any unregistered impounded dog must be microchipped before being released, and any registered dog impounded a second time: Section 69A Dog Control Act 1966
