

# WAIMATE DISTRICT COUNCIL - ENROLMENT FORM FOR RATEPAYER ELECTORS

Enrolments for ratepayer electors can be made by or on behalf of:

- parliamentary electors who are ratepayers within the region, district, or community but whose addresses as parliamentary electors are **outside** that region, district or community;
- legal entities such as companies, banks or bodies corporate who are ratepayers in the region, district or community;
- persons such as joint tenants and tenants in common who are ratepayers in the region, district or community.

*The ratepayer elector and property information will be published in the electoral roll and other information provided may be included on that roll. You may apply to the local authority at any time for the correction of that information.*

## INSTRUCTIONS (please check your rate account)

### Fill in Section A

If you are the **sole ratepayer**
