#### 7.1 HERITAGE FUND APPLICATION: WAIMATE DISTRICT COOPERATING VENTURE -ST MARY'S CHURCH, ESK VALLEY

#### PURPOSE

1. To consider the funding application from the Waimate District Cooperating Venture (Anglican/Presbyterian Parish) for financial assistance to help with the restoration of the stained glass and leadlight windows at St Mary's Church Esk Valley.

#### PROPOSAL

- 2. To restore the windows at St Mary's Church Esk Valley. This will help to ensure their preservation and make them safe for the continued use of the building.
- 3. This ensures that St Mary's Church Esk Valley continues to provide pastoral care, children's activities during school holidays, regular youth group activities, Sunday services, funerals and weddings, etc.
- 4. The total cost of the project is \$37,702.75. The applicant is requesting \$1,000.00 + GST
- 5. All the required information, including written quotes, have been submitted with the application. Grants are now limited to \$1,000 + GST (if any).
