Central Government's decision on the 'Three Waters' is expected in the next week to ten days; and on the 'shovel ready' projects on Friday. This will determine further decisions on significant capital works.

The Mayor commented that the Council was in a positive stance leading into this difficult and challenging time, and that he hopes Council will be able to continue with its capital works programme to retain employment throughout the district.

With maintenance work delayed because of the Covid-19 lockdown period, the Gorge Road Asset Team on return to work will make maintenance work a priority in preparation for winter.

17.4 PRESENTATION – WAIMATE POLICE

Sergeant Brian Ennis updated Council on policing on the Waimate District and thanked Council for its work in the Emergency Operations Centre over the past several weeks. There has been few Covid-19 related issues, however with more people being able to move around this will increase the police's workload. There has been several road crashes over the last few months with two fatalities. Staffing was now at full allocation in the Waimate District. The Mayor thanked Sergeant Ennis and his team for an outstanding job over a difficult time.

17.5 ECONOMIC DEVELOPMENT STEERING GROUP - WHITE HORSE DEVELOPMENT PROJECT - STAGE 1

Council considered the White Horse development concept plan (stage 1) and associated funding request. Chair of the Economic Development Steering Group Ian Moore spoke to the report.

- 7. That Council acknowledges its significant partnership with Waimate2gether on the White Horse Development Project.
